

Notes on the Certificate

This Certificate only applies to the company stated on the first page and the manufacturing facilities mentioned there. It can only be transferred to third parties by the certification body.

The right to use the certificate only applies to those products which correspond to the type sample which has successfully passed the examination and are in line with the information given in the examination report or the supplementary agreements. All necessary operating or mounting instructions have to be supplied with each product.

The holder of the Certificate is obliged to monitor the fabrication of the products fitted out with the symbol in order to ensure that production is carried out in accordance with the examination specifications. The holder of the certificate is particularly obliged to carry out the monitoring examinations which are laid down in the examination specifications or required by the certification body.

Any changes made with products which ensue in a deviation from the examined type sample must be reported to the certification body immediately. The body may base the issuing of the Certificate on the manufacturer's proof that all technical rules have been adhered to or may require an additional examination.

The Certificate can be declared invalid by the certification body (in which case it has to be returned to the body immediately), if:

- the holder of the Certificate relinquishes the Certificate or discontinues production of the certified product,
- the holder of the Certificate does not accept as binding changes in the certification body's terms of business or its remuneration scheme after an interim period of 6 months,
- the holder of the Certificate becomes bankrupt or if a petition in bankruptcy filed against him is ruled for insufficiency of assets,
- any flaws appear after the examination which were not detectable or not found during the examination and which are included in the certification's area of application,
- the certificate is used for the purpose of misleading or in any other way illicit advertising,
- due to facts which were not clearly detectable at the time of certification, further use of the certificate is not justifiable.

The holder of the Certificate is obliged to report any damage to or incurred by certified products to the certification body.

The holder of the Certificate is only allowed to pass on examination reports by using the full text and by stating the date of issue. Publication of excerpts or duplication of the report requires prior consent by the certification body.

The certificate is valid if the EC-surveillance is performed regular according to the Directive 2014/29/EU Article 13(2)b.

The declaration of invalidity may be published by all other Member States and the European Commission according to Article 31 (1).
